## GUIDELINES

- a) Nominations must be approved by resolution at a District or Unit Executive meeting,
- b) Nomination forms must be signed by both the District or Unit President and District or Unit Secretary,
- c) Nominee must sign and date the CONSENT and DECLARATION,
- d) The Nomination form must be received by the Executive Director by June 28, 2012
- e) You may also submit a statement and a curriculum vitae by June 28, 2012 to be included in the File of Reports to be sent out prior to Senate.
- f) A statement of 250 words or less may be submitted in support of the nomination. This statement may include:
  - length of teaching service;
  - teaching related experience (Administrative, Supervisory, Professional organizations);
  - service with RTO/ERO at the District/Unit or Provincial level;
  - service with other voluntary organizations; and,
  - attributes you have that would make you an effective member of the Provincial Executive.
- g) A copy of your Curriculum Vitae.

## NOTE

**Further Nominations may be received from the floor at Senate in accordance with the Provincial Constitution, Bylaws and Policies - Bylaw 5, Section 1 (b).**
