• President's Updates:

Anne presented the Presidents Update for March 29, 2021

- Member Services is no longer responsible for recruitment and RPW's deals with:
 - The needs of current members
 - Recruitment for succession planning

- Recruitment and RPWs now addressed by Marketing and Communications Committee

- The Board approved the implementation of a 4-part **Diversity**, **Equity and Inclusion** awareness training series for the Board and the CEO beginning this month.

• Benefits Committee Report

- The 2020 health plan surplus, the excess fees reimbursed by Johnson and the income from investments in the money Market to cover the projected 2020 health plans deficit was moved to the Health Stabilization Fund portfolio as per the RTOERO investment policy.
- Unprecended surplus in travel claims usually any surplus or deficit is the responsibility of RSA, the company responsible for travel claims plan to share surplus was approved.
- 2020 surplus from 2020 was used to decrease cost of travel in Extended Health Care premium starting in 2021.

Succession Planning/Volunteer Engagement

- Descriptions of the roles of President/VP, Secretary and Treasurer are available.
- Training in Diversity and Inclusion is being planned (didn't state if this was for districts in addition to the Board/CEO).
- **Summary of Legal Responsibilities/Liabilities** for RTOERO members wishing to visit fellow members in hospitals, retirement or LTC facilities
 - Residents have the right to meet with visitors of their choice.
 - Visiting RTOERO members:
 - must call ahead to determine the status of the patient/resident and the visit date;
 - should make the purpose of the visit clear (of a 'goodwill nature');
 - should visit in pairs if possible;
 - must respect the needs and wishes of the patients/residents;

- do not normally need to inform the family before visiting is the person being visited is agreeable to the meeting;
- should immediately seek help if the person starts behaving erratically/disruptively.
- If the <u>patient/resident lacks legal capacity</u> (unable to understand information that is relevant to making a decision concerning the subject matter or to appreciate the reasonably foreseeable consequences of a decision or lack of decision), the visiting RTOERO member:
 - may wish to notify family members in advance;
 - should meet in public areas of the facility;
 - may wish to have a family member present.
- <u>Harm/Abuse of Patients/Residents</u> who are members:
 - If person makes derogatory comments about family member that doesn't raise concerns of abuse, don't respond remain focussed on the reason for your visit.
 - If person talks about family member/facility personnel abusing them, may trigger the duty to report under Long Term Care Homes Act or Retirement Homes Act.

RTO Political Advocacy Report Executive Meeting March 2021

- RTOERO has a very active, strong political advocacy committee and strong commitment for political advocacy from the Board and Senior Staff
- The Vibrant Voices Webinars have been outstanding. Experts in the field have presented us with valuable information and have motivated us to advocate on behalf of seniors in Long Term Care Homes.
- I have used the information in the last one The Aging Continuum to write my article for our newsletter and to write another letter to the MPP's.
- At the end of April, there will be a final report and recommendations from the commission looking into the deadly impacts of COVID-19 in long-term care homes. We will follow up again with politicians to discuss those recommendations.
- There is a regional PAC ZOOM meeting on Wednesday which I will attend.
- Also, I strongly recommend that members tune into the Zoom Vibrant Voices Webinar on April 29 at 1 p.m. The topic is "Our Earth". I know we are focusing on LTC Homes BUT this is a crucial topic too and maybe we could follow up with some action here too.
- Finally, ETFO has sent out an excellent petition for supporting the idea that teachers and educational workers should receive vaccinations sooner rather than later and that during the Spring Break in April would be an ideal time especially since outbreaks in schools are definitely on the rise. Also, this email provides good information on Minister Lecce's plans to make on-line learning permanent.
