• Health – Shirley Goodbrand

Shirley reported that the benefits update can be found in the Communique newsletter.

- There was a surplus so there will be a 3% reduction in Health Benefits for 2021 and a subsidy for the next 5 years.
- Dental coverage will be based on the 2021 schedule.
- There will be a new online website for claims with Johnson in 2021.
- Trip cancellation or interruption is not covered if it relates to COVID but it will reimburse expenses if they are unrelated to COVID.
- All claims incurred in 2019 must be submitted by December 31, 2020.

• Membership/RPWs – Scott Montgomery

Updated district 31 numbers from the November Membership Lists: 1384 members in total, 8 members who have passed away, 3 new members (2 were spouses of deceased members), and 37 active teaching members
