Reports: Treasurer:

A grant of \$6257.93 was received. The balance is now \$11070.28.

Denyse has expense and mileage forms that are to be used by members of the executive. It was suggested that the executive offer invitations to members of Parliament to our dinners and luncheons. A motion was put forward by Denyse to destroy receipts from 1990 to 2000 with the exception of the final report for each year. Seconded by Terry Sullivan.

Membership:

Mike Curtis noted that retirements will be down in number to 15 to 20. Letters and kits will be sent out to those retiring.

Health:

The rate increase has produced a modest surplus. 86% of premiums go to claims. There is a new process in place for appealing non-payment of claims. Members are to call the health plan "RTO" not Johnson. Be aware that there is a government grant of \$1500.00 per year available to severely disabled persons. There will be two minor amendments presented at the Spring Meeting. There will be a Health Conference in June. Please forward any questions to Bob Paul. Stephen suggested a comparison chart OTF/RTO coverage be put in an upcoming Newsletter.

Newsletter:

The Newsletter went to the printer on Friday. It will go to Arc Industries on Wednesday and hopefully be out by the beginning of next week.

It has been sent to John Ritchie to put on the website. Fall Newsletter submissions are due September 4th. The Newsletter will go out the week of September 17th.

Goodwill:

Pauline noted that with 10 members on the Goodwill Committee there is a lighter work load for everyone and more can be accomplished. Since Christmas the Committee has received 13 replies and 1 phone call concerning the wish to be remembered on special occasions. A number of cards were "returned to sender" so it is important that our lists be updated. It the last three months, there have been 18 cards mailed, 7 visits, 5 telephone calls and 1

bouquet sent our to our people. The March 28th meeting was changed to April 4th as there was a conflict with the Guelph Retired Women Teachers' meeting.

Political Action:

RTO encourages members to become involved with the political process. Provincial election will be on October 10th. There are rumors of a Federal election, possibly in the spring.
