Polítical Advocacy



The provincial election will take place on Thursday, October 6, 2011.

The Provincial executive, with input from the Political Advocacy Committee, developed a list of provincial issues deemed important by RTO/ERO members

for advocacy purposes and distributed these to the Districts in the spring. An insert on these issues was contained within the summer issue of *Renaissance*. Also, advertisements outlining RTO/ERO's provincial issues will be placed in weekly newspapers delivered free to residents in each of our 46 Districts in Ontario.

It is important to note that RTO/ERO is a non-partisan, issue-based organization. RTO/ERO does not support any political party, but will meet with members of all political parties to promote its issues and positions.

It is also important to note that as informed, caring individual citizens we have the right to become actively involved in the political campaigns of candidates who represent our views. Nothing is more rewarding than working hard on the campaign of a candidate whose ideas you support.

As has been stated many times too, the encouragement of eligible citizens of all ages to participate in the democratic process by voting is one of RTO/ERO's key philosophies at times of election. So, let's not just get out and vote, let's encourage others to do so as well.

Some Key Issues for RTO/ERO :

RTO/ERO's 65,500 members share the view of most Ontarians that the province's highest priority must continue to be timely access to quality health care.

RTO/ERO seeks a re-affirmation of a commitment to the principles of the Canada Health Act and to the provision of adequately funded programs and services that ensure timely and equitable access.

RTO/ERO believes it is essential that a provincial government makes a commitment to the provision of adequately funded programs and services, as well as tax rebates that allow and encourage seniors to age with dignity.

RTO/ERO recognizes and appreciates its diverse membership of educators and support staff from Public,

Catholic, French, Elementary and Secondary schools, Colleges and Universities. The majority of its members helped to build and strengthen the publicly-funded education system in Ontario. RTO/ERO, therefore, remembers and respects those still teaching and working in the school system and has a position that states : "RTO/ERO also recognizes that the future growth of the province depends on a quality, publicly funded education system".

Over the next little while, as the provincial election campaign intensifies, and, as members consider which candidates to support, we are encouraged to determine how well the candidates' views mesh with our own and those of RTO/ERO.

Members are encouraged to carefully review campaign literature and attend all-candidates' meetings which we will post on our website as these dates become available.

Members are reminded that we have a lot of political influence. Politicians know that we vote. They listen to what we have to say. There was much media attention given to the "youth vote mobs" during the last Federal election. Sadly, these events did not result in larger voter turn out among the younger population. Seniors, though, continued to have the highest percentage of voters. Use your influence to lobby for our causes.

I also leave you with this final extremely relevant thought: "Those who cannot remember the past are doomed to repeat it."

All of us strongly support the goals and work of the United Way. We have just lost the opportunity to contribute to the campaign in a convenient fashion. Enclosed with this newsletter is an opportunity for you, if you choose, to continue to contribute to this year's United Way Campaign.

In reviewing the work of the United Way, I have been reminded that contributing to the United Way is a great way to help all kinds of groups in our own community.

This year, United Way will support over 80 vital social and voluntary sector programs at 50 organizations in Wellington County and the City of Guelph. Chances are these programs will help someone we know –our family, friends, neighbours – every day.

In 2010, donations to United Way helped :

- Action Read Community Literacy Centre provides specialized, computer-based, literacy training to 92 people;
- Chalmers Community Service provides food and basic necessities to 4,145 visitors at their downtown food pantry;
- Community Torchlight volunteers answer to 12,400 calls to Distress Line;
- Food & Friends serves 15,800 meals and snacks to 12,000 students at 69 local schools;
- Guelph-Wellington Women in Crisis provides more than 3,600 hours of counselling through the Rural Women's Support Program.

This is just a very small sampling of the ways that donations to United Way are helping people in our community.

We are constantly being asked to contribute to many excellent causes. We can't, of course, contribute to everything we'd like but a contribution to United Way is a very cost effective, efficient method of donating. The United Way's volunteer board of directors assures us that our donation will be directed to where it will have the greatest impact, stay in Guelph and Wellington County, and provide stable funding to maintain programs for those in need.

Pension Matters



In the spring newsletter, I provided a detailed summary of proposed changes that were being addressed by the Pension Partners. On July 6, 2011, the Ontario Teachers' Federation and the Ontario government agreed to a three-part plan to address the projected 17.2 billion funding

shortfall in the Ontario Teachers' Pension Plan. The proposed changes were approved and will be implemented on January 1, 2012. These changes include:

- a 1.1% contribution rate increase phased in over the next three years;
- slightly smaller annual cost-of-living increases for teachers who retired after 2009;
- recognizing the current contribution rate as the permanent base rate.

Funding challenges will likely continue in the immediate future because of the uncertain economic conditions worldwide.

Retired teachers are in an enviable position! We may never be wealthy but we are fortunate to have a guaranteed pension income to sustain a healthy lifestyle.

Our provincial health care system is admired by people from all over the world.

Canada's immigration policy is to allow 250,000 people to immigrate each year; however, in the last few years just under 290,000 people have been allowed to settle in our great country. Is it our vastness or our Health Care System?

Our Health Care System is sometimes compared to a hospital gown. You think that you are fully covered when you reach age 65, but you're not. That is why our benefit plan is great. It helps to pay for these additional costs.

Always remember that if you are in hospital, everything is <u>usually</u> covered but if you are an out-patient, you usually have to cover additional expenses out of your pocket. (Submit a claim to Johnson Inc.)

Independent Review of Extended Health Plans by Coglin Employee Benefits Specialists

In April of 2011, an independent review of your health care benefit plans was done by Coglin Specialists. They said that our RTO/ERO plan is equal to, or superior to, other plans in most areas of Ontario. Our plan is superior to plans offered by elementary and secondary employee and support staff by our competitor RTIP. Your plan is a group plan and, as a member, <u>you own it</u>. **Johnson administers it**. Members are getting good value from their plan but there are some recommendations which are currently being investigated. Our travel plan is superior to them all. It is rather comforting that, as a group, we all pay the same premiums. Not so with other plans where, as members age, the premiums increase. The last point that I will mention is that the reviewer felt that our plans were more grounded to our membership's needs and feedback.

Points of Interest/Review

1. The average age of an RTO/ERO member is 71.

2. **OHIP** delisted 2,200 drugs between 2009/10. Some generic drugs took their place. The bottom line is less drugs that are covered by OHIP are available for your physician to prescribe.

3. Organ Donor Registry: Remember that old piece of paper that you had in your wallet with your driver's license. It is no longer valid. You have to go online and and fill out the registration forms from <u>www.giftoflife.on.ca</u>. The website is run by the Trillium Gift of Life Network, which is the province's central donation agency. Donors then mail the forms to Service Ontario or take them to their local OHIP office to expedite registration. Many states have this donor identification put on their driver's license. To my knowledge, no province has this. Wouldn't it be nice if Ontario was the first province to do this and therefore save more lives? Organ donations in Ontario saved 218 lives in 2010.

4. Asbestos: Having spent the last 17 years of my teaching career involved with Health & Safety and still being an active instructor for the Worker's Health and Safety Centre, I am so glad that most schools are free of chrysotile asbestos. A few schools have some but it remains encapsulated and safe. Our new teachers and students are safe. I find it extremely disturbing that Canada still exports, from Quebec mines ship-loads of this stuff to India and will continue to do so for the next 50 years. Our current Federal government continues to support this practice. Brake material for automobiles has not used asbestos for close to 2 decades. Why? Excessive

WSIB claims from auto mechanics.

5. **Trips and Falls:** 20% of injury-related deaths among seniors can be traced back to a fall. Hip fractures are the most common. Start now to de-clutter. To get started read "healthmatters", the December 2010/February 2011 article that you will find on-line. It is well researched and written.

6. Travel Insurance: You know that you are covered for 62 continuous days while out of province or country; however, many people fail to document their departure date and therefore it takes a long time to get your claim settled. Buy something from Duty Free and charge it to your card. It's that easy.

There are so many issues to deal with concerning Health. I hope that this brief read will help you become a little bit more aware of issues.


