Provincial RTO/ERO sent us the following information about an event taking place at the end of September at Under the aegis of the Ontario Queen's Park. Gerontology Association (OGA), RTO/ERO has been working in conjunction with other groups to plan an event at Queen's Park that will raise the profile of the needs of seniors/older adults on a variety of issues with MPP's and the media. This group, which includes the Ontario Network for the Prevention of Elder Abuse, the Ontario Community Support Association, the United Senior Citizens of Ontario, the Ontario Society (Coaltion) of Senior Citizens' Organizations, the Ontario Association of Non-Profit Homes and Services for Seniors, and the Older Adult Centres Association of Ontario, has worked together for the past few years, submitting joint papers to the provincial government. One example was a paper entitled "priorities in the Field of Aging" submitted prior to the last provincial general election.

RTO/ERO is very pleased to announce that on Monday, September 30, our group will sponsor the first annual "Older Adults Day" at Queen's Park, in recognition of the United Nations International Day of Older Persons which occurs each year on October 1st.

Representatives from each of our organizations will meet in the morning at Queen's Park at about 9:30 a.m. to proceed into the Legislature and occupy one of the two public galleries and attend Question Period, which lasts about an hour. Plans have been made, through the office of the first-ever Minister of Seniors to have our group recognized in the House and hopefully have an announcement from the Minister related to funding for a program for seniors.

Following the conclusion of Question Period, our group will gather in one of the large assembly halls at Queen's Park to meet with the Minister of Seniors, Mario Sergio, other available cabinet ministers, and hopefully Premier Wynne. A spokesperson from our group will address the gathering and members from the various organizations, including RTO/ERO, will have the opportunity to meet with their MPP's to discuss the identified issues.

We wish our group great success with this initiative and look forward to reading reports about this endeavour.

On Tuesday, August 20th, during the Association of Municipalties of Ontario AGM and Annual Conference, Mario Sergio, released a guide to help communities across Ontario keep their seniors healthy, active and engaged in community life by helping them live safely, independently and with dignity. The guide helps municipalities assess community dimensions, define local principles, conduct needs assessments, develop and implement an action plan and evaluate progress. We will be following the implementation of these plans in our communities.

A number of seniors have been very concerned about physiotherapy services. We have been reassured that eligibility for physiotherapy remains the same. By changing the model for delivering these services, more seniors can benefit from physiotherapy and exercise classes in long-term care, retirement homes and in community settings. Seniors with assessed need will be able to benefit from individualized physiotherapy, either in long term care, at home or in community clinics. Seniors who are able to go to a clinic to receive physiotherapy will have many more locations to choose from. For more information about access to exercise and physiotherapy for seniors, please visit www.ontario.ca/physiotherapy or call the Seniors INFOline at 1-888-910-1999.

We have also been informed that the Municipal Property Assessment Corporation (MPAC) has become aware that people are placing phone calls to property owners claiming to represent MPAC and asking for personal information. MPAC has reported these incidents to the Ontario Provincial Police. MPAC does NOT make calls to collect personal information. If you receive a call from anyone claiming to represent MPAC and requesting personal information, please do not provide it. If you receive such a call, please contact MPAC's Customer Contact Centre at 1-877-635-6722.

Finally, Richard Goodbrand and I are really looking forward to attending the RTO/ERO Political Advocacy Workshop in Toronto on September 15th and 16th. I am sure we will receive some great ideas for political advocacy in our district.

## Pension and Retirement Concerns



#### Ontario Teachers' Pension Plan Annual Report 2014

The OTPP Annual Meeting was held on April 11, 2013 at the Carlu Hotel in Toronto, Ontario. Highlights of the 2012 Annual Report included:

- 13% rate of return on its investments last year
- 9.6% 10-year annualized rate of return
- Net assets 129.5 billion
- OTPP plan 97% fully funded
- 5.1 billion gap between projected assets and liabilities
- Members Service Satisfaction rating 9.1 on a 0 10 rating scale
- 179,000 active members
- 124,000 retired members

The main cause of the funding deficit (gap) is continuing low interest rates combined with the financial loss during the 2008 and 2009 financial crisis and the changing demographics of the membership. Members of the plan work an average of 26 years before retiring and are now retired for an average of 31 years due to longer lifespans in Canada. There is also a falling ratio of working teachers compared to retirees, and OTPP says its members – many of whom are women – have the longest longevity of any pension plan in Canada, with 2,800 pensioners now over the age of 90 and 107 over the age of 100.

The Ontario government and the Ontario Teachers' Federation recently reached an agreement to end guaranteed indexing of pension benefits for teachers to help the plan return to fully funded status. Going forward, any new pension service earned by teachers will only be indexed to inflation if the fund has a surplus to pay for the benefit. Former service previously earned will continue to be subject to inflation protection.

Jim Leech, Chief Executive Officer of OTPP, said traditional defined-benefit pension plans like OTPP are the best solution for providing retirement incomes, but said the model must evolve and continue "building flexibility" into the cost of providing benefits to ensure plans can remain affordable. The OTPP is one of the best defined-benefit pension plans. It is well managed,

governed effectively and is the model for other employer-employee pension plans. As a leader in pension plans, OTPP and the Pension Partners (OTF and the government) must advocate to make pension plans available for all workers and citizens in Canada. Pension reform and an improved Canada Pension Plan must be addressed to safeguard the future of Canadians. Public sector employees must lead the way to improve working conditions, guarantee health benefits and secure decent wages for all workers. The current "corporate model" must be challenged and made accountable to share the profits with the workers. The fabric of Canadian society must be sustained through good jobs, and health and pension plans for everyone. The corporate world must return to a sustainable investment plan that addresses the social welfare of its employees. Currently, 1% of the population controls 33% of the financial wealth in Canada. This unequal distribution of wealth has devastating effects for everyone. Union workers have an important role to play! Each of us must work for the collective good of society! Teachers are fortunate to have the opportunity to contribute to a defined-pension plan and to have these contributions matched by their employer. Let's eliminate pension envy by supporting others to secure a decent retirement income.

#### **Ontario Teachers' Pension Plan**

In order to appreciate how fortunate we are, it is important to think about the past so we can realize the reality of our time – our Pension Plan and then our RTO/ERO benefit plan.

In 1917, a Teachers' Superannuation Fund was established for teachers by the Ontario government. From 1917 to 1990, the Pension Plan was controlled by the Ontario government. Prior to 1990, the funds were invested in province of Ontario debentures for the most part and the unfunded liability kept growing to almost \$8.4 billion. Think about what your pension would look like today if that hadn't changed.

In 1990, the Ontario government passed legislation to establish the pension partnership (the Ontario government and Ontario Teachers' Federation). The Teachers' Superannuation Fund became the Ontario Teachers' Pension Plan. The government was required to pay more than \$8.4 billion to eliminate the initial unfunded liability. The Partners' Agreement required both partners to equally share any future unfunded

liabilities and/or implement benefit enhancements if there was a surplus.

OTPP attained global distinction in 2007, 2010, 2011 and 2012 for being among the best managed plans. OTPP is the third largest pension plan in Canada and ranks in the top twelve pension plans in North America.

In 2012, OTPP had 303,000 members; 124,000 members were pensioners. In 2012-13, 2700 active teachers became pensioners. The provincial government has implement a two-year teaching training program that will reduce the number of new graduates each year.

## Health Matters



As you read this, we are into a new season. Over the past several months, issues and benefits continue to evolve. First, a few highlights from the 2013 April HSIC Meeting.

- The HSIC voted to suspend any further review or discussion on catastrophic drug coverage due to the cost. "It is outside of the mandate to meet the needs of the majority of members at the most affordable costs." You realize that medications for these serious illnesses cost up to \$4,000 per month.
- There will be new member ID cards for all Health Plan participants. The cost is \$72,540.35. You should be receiving these ID cards with your new benefit booklet in late November.
- Health Matters will continue to be published for one additional year (2014 funds approved).
- Supplemental Travel Plan has run a deficit. The current premium is insufficient to cover the claims. Your HSIC has decided to move the premium to an age-banded basis. In simple terms, it means that all members have the 62-day travel insurance medical coverage; however, if you require an extra week of coverage and, for example, you are in the 80-90 year age group (which has higher claims), you will pay more for that extra week. The 60-70 year age group with lower claims will pay less. It stands to reason that the younger age group has proven to have smaller claims. If this action was not taken, everyone would pay more starting in January 2014. These age-banded premiums are effective September 1, 2013 for the Supplemental Travel Plan only.

#### Johnson Consulting

Since we own our benefit plans, have you ever wondered what it costs to administer the plan? In 2013, the consulting fees for reconciliation came to \$532,000, which was \$7,000 over budget.

#### Dispensing Fees

How can you find out which pharmacy has the lowest fees? The Ontario College of Pharmacists does not publish this information. It is up to you to compare fees. Costco still continues to have the lowest fee for people under the age of 65. Many other pharmacies, such as Walmart, Zehrs, etc., have similar low prices. Choose the one with whom you're happiest.

#### Shoppers Drug Mart

RTO has a partnership which includes a 20% discount on appliances and bonus Optimum points. At this point in time, I haven't seen any benefit for me personally; however, as I age, there is a possibility I may. With Loblaws merging with SDM and it adding produce and more groceries, maybe everyone can benefit on senior days.

#### RTO and New Partnerships

In the Health column of the summer issue of Renaissance, you will notice that we will have some new common elements for consideration when we are looking to partner with other for profit organizations. If you receive the Zoomer magazine (also a targeted audience), you will notice similar Merit Travel and SDM ads. I believe the newer partnership agreements which are being developed will be more transparent.

#### **Benefit Limits**

Keep in mind that your benefits have a yearly calendar maximum. For example, if you realize that you will go over your dental limit when you visit the dentist in December, cancel that appointment and make it for January when you have new coverage. Members who use a considerable amount of medications tell me that they always have an extra month's supply of meds left when they order new ones.

#### Wellness Workshops

What a success! Expect to see more in 2014.

#### Health Costs

In order to put our health care costs in context, it's useful to compare them with those of France, which generally is acknowledged as having one of the world's best health care systems. Like the Canadian government, the French government sets the prices. A comparison to the U.S.A. is also useful because many RTO members take extended holidays there.

Doctor's office visit cost:

France - \$30 Canada - \$35 U.S.A. - \$95

Hospital cost per day:

France - \$850 Canada - \$1,300 U.S.A. - \$4,300

Hip Replacement cost:

France - \$11,000 Canada - \$ N/A U.S.A. - \$40,000

Heart Bypass cost:

France - \$23,000 Canada - \$30,000 U.S.A. - \$73,000

Lipitor 20mg cost per day

France - \$1.60 Canada - \$2.45 U.S.A. - \$4.13 (Generic Lipitor—Costco - \$0.47)



When you reach age 65, you are automatically enrolled in the **Ontario Drug Plan** and will receive generic prescriptions. You can save money by using generics if they meet your needs. (Sources: Organization for Economic Co-operation and Development and International Federation of Health Plans)
