There are also representatives from ETFO, OECTA, OSSTF, Council of Canadians -Guelph Chapter, Wellington Water Watchers, University of Guelph - Student Association, Fair Vote Guelph, Guelph Wellington Health Coalition, Guelph & District Labour Council, Development & Peace - Hamilton Diocesan Council, Registered Nurses Association of Ontario - Wellington Chapter, Ontario Public Interest Research Group, and KAIROS which promotes 'a more just and sustainable world'. Polítical Advocacy Brenda McGinnis



Political advocacy on seniors' issues continues to be a focus for RTOERO.

Our Board of Directors has asked us to share the following extremely important information with you.

Our mission at RTOERO is to improve the lives of our members and all seniors in Canada. One main way we fulfill this mandate is through vigorous advocacy on issues that affect members, seniors and, in fact, all Canadians. This mandate has never been more important than right now.

One of our major areas of concern is the long-term residential care facilities.

The Chair of our Board, Martha Foster, and our Chief Executive Officer, Jim Grieve, sent a letter to the Prime Minister, the Premiers and all Ministers responsible for seniors and health care in every Province and Territory in Canada. The letter outlined immediate actions that were needed to stop COVID-19 spread in these homes and action needed after the crisis has subsided.

The letter states: "For decades across Canada, long-term residential care has languished despite the calls for reform for help. The sector has been characterized by under-funding and a lack not only of enough staff, but of appropriately skilled and compensated staff. Sadly, it is no surprise to anyone that around 50% of the deaths in Canada due to COVID-19 have occurred in long-term residential care facilities."

To keep up the momentum and to focus on vital transformation needed regarding long-term care in Canada, we are encouraging our members to let your elected officials know your views.

To assist members in contacting your federal and provincial elected representatives, we have created an easy-to-use form on our advocacy website.

1) Go to <u>vibrantvoices.ca</u>. There you can read our position papers on geriatric health care and seniors' strategy, to learn more about the issues.

2) On the page is a self-serve form to send a message to your elected officials. Simply fill in your name, address and email address.

3) Once you have added your mailing address, the form will show you federal and provincial elected officials. You can choose to send your message to either one or both.

4) We have helped you get started with messaging that reflects RTOERO's advocacy messages on the issue. We encourage you to personalize the letter with your own story, which you add to the form.

5) When finished, click on the 'Add your Voice' button. Your message will be mailed to the officials you selected.

6) You will receive an emailed copy of your letter for your records.

We know that governments are paying attention. By sharing your views with your elected representatives, you can help keep this issue at the top of the government's agendas.

As I write this, another important issue that has been on the minds of many of us is the safe return of children, teachers and staff to school this fall. As parents, grandparents and seniors worried about another surge in outbreaks of the virus, we have a very vested interest in this issue. As individuals, we can support our colleagues in the unions by visiting their websites and offering our support. I know many of us have signed petitions and made our voices heard about providing the necessary conditions for a safe return to school for everybody in Ontario.

All of us can become strong political advocates for these two very important causes from the safety of our homes.

Annual Reports

OTPP, April 2020

On March 31, 2020, the Ontario Teachers' Pension Plan released its

results for 2019. For a seventh consecutive year, the Plan was fully funded and had a funding surplus of \$6.1 billion as of January 1, 2020. Net assets reached \$207.4 billion, a \$16.3 billion increase in investment income in 2019. OTPP earned \$20.2 billion in investment income in 2019, the highest earnings in OTPP's history.

The Ontario Teachers' Federation (OTF) and the Ontario Government, as co-sponsors of the Plan, decided to file the January 1, 2020 funding valuation with the regulatory authorities and to classify the \$6.1 billion surplus as a contingency reserve. The purpose of the contingency reserve is to reduce volatility in the Plan's funded position and to facilitate stability in Plan Members' contributions and benefits. It will also provide inflation protection for the next three years because another funding valuation is not required until 2023.

Filing a funding valuation in January 2020 was a very significant decision prior to COVID-19. In the midst of the pandemic, OTPP announced its mid-year report (June 30, 2020) showing a total net fund loss of 0.4%. The net assets were reduced from \$207.4 billion to 204.7 billion. COVID-19 has had a devastating impact on the global economy. Financial markets have experienced unprecedented volatility

and significant challenges for investors. OTPP has been quite resilient with its high-quality portfolio and long-term investment approach but must remain focussed and vigilant to weather the financial outcome and determine the full impact of the pandemic. In the midst of the financial crisis, a loss of only 0.4% is a significant statement about the strength of our pension plan.

OMERS Annual Report 2019

OMERS reported net assets of \$109 billion, up from \$97 billion reported in 2018. The 2019 net investment rate of return was 11.8% which represents a 9.6% increase from the previous year. The plan is 97% funded.

OMERS is a high-quality, well-diversified portfolio which has produced strong results for its members. OMERS funded status has improved for the seventh consecutive year and is on target to be fully funded by 2025. Despite the challenges of the pandemic, OMERS remains focussed on its strategy to offer a sustainable, affordable and fully-funded plan for its members.

Significant changes were implemented as a result of the 2020 Comprehensive Plan Review for the OMERS Membership. Effective January 1, 2023, Shared Risk Indexing will be implemented. Shared Risk Indexing means that inflation increases (cost of living increases) will be conditional on the financial health of the Plan. Benefits earned on or before December 31, 2022 will be granted full inflation protection and benefits earned on or after January 1, 2023 will be conditional on the financial health of the Plan.

Another important change is the removal of the 35year cap on pension contributions. Effective January 1, 2021, Plan members will not have the credited service capped at thirty-five years. Members who continue to work beyond the usual retirement date will be eligible to continue to contribute to the Plan and gain additional credited service. This will increase the members' pension income at retirement.

As a result of the pandemic, new provisions were introduced to allow Plan members the opportunity to purchase credit for the period of time lost because of temporary lay-offs.

Important Travel Update

(Published by RTOERO on August 13, 2020)

This is important information for members with RTOERO travel insurance coverage. As you know, for now the global travel advisory from the Canadian government remains in place. That means the government is telling Canadians that public health officials do not consider international travel to be safe. RTOERO will communicate directly with all members as soon as the advisory status changes.

The following answers are based on the questions we are receiving.

Q. Am I covered for travel within Canada?

A. Travel within Canada is covered. Please follow the COVID-19 restrictions issued by the provincial and municipal public health officials for the area(s) you plan to visit.

Q. Am I covered for *trip cancellation/interruption* if I'm travelling in Canada?

A. Yes. When travelling in Canada, you remain covered for trip cancellation or interruption as described in pages 72 to 76 in the RTOERO Insurance Plans Booklet.

Q. If I become ill with COVID-19 while travelling within Canada, am I covered?

A. Yes. Emergency Medical coverage is available as long as you have not experienced any symptoms prior to leaving.

Q. If I choose to travel outside of Canada despite the government travel advisory, am I covered for medical emergencies?

A. You are covered for medical emergencies, except for claims related to COVID-19, while the government travel advisory is in effect. This is a <u>new enhancement</u> to your travel coverage. You will receive additional communication regarding this change shortly.

Q. Once the travel advisory is lifted, am I covered if I become ill with COVID-19 while travelling?

A. Yes. Emergency Medical coverage is available as long as you have not experienced any symptoms prior to leaving.

Q. Am I covered for cancellation of international trips?

- A. You are not covered for trip cancellation related to COVID-19 for trips booked during the government travel advisory.
- For trips booked after the travel advisory is lifted, you will be covered.
- For complete details of trip cancellation/interruption coverage, see page 72 to 76 in the RTOERO Insurance Plans Booklet.
- If you receive a voucher instead of a refund, you can submit a claim for any unused portion if it expires.

Q. While travelling *outside Canada*, if I come home early, will I be covered for trip interruption?

- A. You are covered for reasons outlined on page 72 to 76 in the RTOERO Insurance Plans Booklet.
- While traveling outside Canada, you are **not** covered for trip interruption related to COVID-19 during the current travel advisory.
- For interruptions after the advisory is lifted, you will be covered for reasons related to COVID-19

Q. While travelling, will I be covered if my return flight is cancelled?

A. The airline and/or travel agency normally provides a voucher or refund in this situation.
