

President's Message



Happy 2014! I hope everyone has a very happy and healthy new year!

I am one of those people who make New Year's Resolutions. Sometimes I am really successful at keeping them and, at other times, not so successful, but I do think it's

important to always try to keep improving the way one leads one's life. One resolution that I made and have kept for many years is that of sending cards to family and friends on their birthdays and on special occasions throughout the year. I love sending and receiving cards and letters and I think most people feel the same way. A new resolution I made this year is to clean and organize every drawer and shelf and cupboard in our house. I started cleaning out some drawers in a desk and discovered an absolute treasure trove of old greeting cards and letters. I spent a thoroughly enjoyable afternoon reading and appreciating these old gems some of which were from people who are no longer with us in this world. Needless to say, I did not throw out a single card, note or letter – I just jammed them back into the drawers to be enjoyed again at some future date.

Getting and receiving mail is very important and, excluding bills, is very precious to most of us. From the feedback that our executive receives, this view is shared by our members. Our over 80 years of age members really appreciate receiving birthday and Christmas cards from their friends and colleagues in District 31. All members appreciate the Sympathy and Get Well and Congratulation cards that we mail. We also know from the positive and constructively critical feedback that we receive from our members that they enjoy receiving their newsletters by mail. This is why so many of us are extremely annoyed with Canada Post and its attitude toward mail delivery and service.

Canada Post announced on December 11 that it would phase out home deliveries to five million homes as part of its new five-point plan. This move has greatly upset many seniors and people with physical disabilities. What is really annoying is that Canada Post announced this change in home delivery as a done deal when the House of Commons was in recess so that the issue could not even be properly questioned or debated. Moreover, the CEO of Canada Post made some dismissive and patronizing statements about seniors and is not at all open to other suggestions for saving money without reducing level of service. To add insult to injury, Canada Post is also significantly increasing the cost of stamps. This increase will greatly impact our District 31 budget and we'll have to carefully prioritize our spending in order to maintain our present communication with members. On top of that, 8,000 jobs will be lost in our economy which desperately needs some job creation and stimulus. I have also read in several reports that the CEO of Canada Post received a 33 per cent bonus even though the company was losing lots of money. I am hoping this is not true. In any case, what can we do?

One thing we can do is sign a petition on <u>change.org</u>. We can phone, email and write our MP's. We can join CARP and other senior groups in protesting these changes and asking for further discussion about other possible suggestions for saving money without reducing service and increasing costs of stamps so outrageously. While it doesn't seem hopeful that things will change at this point, we must try to make our views known to Canada Post.

I am also very aware that many of our members enjoy their computers, email, and smart phones very much. I am among that group. As always, we encourage you to check out our website, www.rto31.org, which John Ritchie tries hard to keep up to date. Also, you might want to subscribe to *Liaison* which is a newsletter that is full of news and information from Provincial RTO/ERO. You can sign up by sending your name, District name and number (Wellington, 31) and membership number to liaison@rto/ero. The December 13<sup>th</sup> edition of Liaison features, among many other interesting items, information on a Travel Photo Contest, an invitation for submission of artwork for the next cover of the pocket calendar, and an invitation to submit ideas for *Renaissance*.

As always, we invite your comments and suggestions. Have a safe and happy winter! Avoid falls! Statistics show that one in three seniors over the age of 65 is likely to fall at least once per year and seniors 85 and older are 3.4 times more likely to fall than the general population! All the more reason to speak up against Canada Post's proposal!

So many issues...so little space!

As usual, there is a fraudulent email and rumour making the rounds. This e-mail states that the Ontario Ministry of Transportation will be administering a test called the Simard Test to all drivers 65 years of age and older to determine if they have dementia. The email says that this test will cost seniors \$250 and will be introduced in April of 2014. This is absolutely not true. The Ministry of Transportation has no plans to introduce SIMARD testing and no plans to increase costs to seniors for driver testing. Drivers over 80 will still be required to renew their licenses every two years because research has found that drivers aged 80 and over have collision rates that are much higher than those observed for drivers in middle age and are comparable to the collision rates observed for young drivers who are also subject to specific licensing requirements on the basis of their age. We have also been informed that some changes may occur to the over 80 driver licensing process in the near future but these changes are designed to streamline the process and will not involve a cost increase to seniors. I'll report on these possible changes in the next newsletter.

A group of concerned citizens has a wonderful suggestion for the development of part of the old Guelph Correctional Centre. These citizens would like to secure designation of 36 acres for diverse small-scale agricultural initiatives, the superintendent's house and the gate house for demonstration and education/activity centres, and the administration building as an exposition of best practices for environmental innovators, related businesses, NGO's, and outdoor and historical educators. Our provincial government will soon decide on the development or adaptive re-use of the publicly owned GCC lands and buildings. Please visit the York Lands Green Hub website: www.yorklandsgreenhub.ca and learn more about this exciting idea and consider endorsing the initiative by signing the petition to the Ontario Legislature. Everyone who hears about this project is very positive and enthusiastic about it. Many groups and organizations are supporting it and I will be asking our executive to endorse this idea. If there is

enough support and interest, MPP Sandals will introduce the suggestion to the Legislature. I strongly encourage you to visit the website and sign the petition!

I would like to conclude my article with some more very positive political news :

The new Ontario Seniors Community Grant Program will give seniors more opportunities to participate in their communities by providing funding to not-for-profit community groups for projects that encourage greater social inclusion, volunteerism, and community engagement for seniors across the province. It's the first ever grant program in Ontario dedicated solely to helping seniors.

In 2014, Ontario will become the first jurisdiction in North America to eliminate coal-fired power, a huge environmental achievement for our province. Transitioning from dirty fuels is good for our planet, our economy and our health.

The Ontario Government made history by becoming the first province in Canada to pass a tax credit for farmers who donate agricultural product to local food banks. Beginning in January 2014, farmers will receive a 25% tax credit based on the fair market value of the product that they donate to food banks. Farmers and food banks play an important and necessary role in providing hunger relief to thousands of Ontarians each month.

The province's grape growers harvested a record 79,756 tonnes of grapes valued at nearly \$100 million. These grapes will produce enough wine to fill the equivalent of 1,134 Olympic-sized hockey rinks.

Finally, I hope that you have watched the CBC's production of the hilarious book *The Best Laid Plans* – a truly excellent satire of Canadian politics!

Out with the old and in with the new is a statement we have heard many times. Behind us is 2013 and a new year has begun. In 2012, we saw the CPI increase 1.52% and just under 1% in 2013. If you live in Kitchener, your home tax increase in 2013 was 1.39% while, in Guelph, it was 2.97%. Your interest

rates on term deposits are low; however, the stock market has reached an all-time high. So what do these numbers have to do with health benefit costs?

#### **Benefits:**

We have to put many of these numbers behind us as our OTPP increase was 0.9% in January 2014 so the average pension increased by \$340 per year and, as expected, your health benefit costs also <u>increased/decreased –a</u> 2.5% increase for Extended Health Care Plan, 0% increase for 2014 ODA fee schedule for Dental (ODA rates did increase 2% for 2014) and a <u>10% decrease</u> for Semi-Private and Convalescent Care Plan.

With the small increased benefit cost also comes increased benefits. I will mention briefly some of these benefits:

- Prescription Drugs \$3,000;
- Paramedical Practitioners \$1,000;
- Prescription Eyewear \$325 every 2 years;
- Travel Benefit by supplying up to \$1,500 airfare for a member of your family to accompany a spouse or companion home due to an interrupted or delayed trip due to hospitalization.

There are more benefits that I would encourage you to read in your **RTO/ERO GROUP BENEFITS Update 2014.** The enhancements I feel are worth the slight increase in premiums.

#### Travel:

Everyone knows the rules about "Proof of Departure" and Medical Stability clauses in your benefit package. I would encourage you to review them before travelling. Carry your new Benefit Card with you. Notify your credit card companies of the dates of your departure and possible charges. Some countries now require a 5 digit PIN number vs. our North American 4 digit PIN number.

#### Trip Cancellation/Interruption:

We have great insurance. It covers you up to \$6,000 per trip per person. Here is something you may not have thought about. In the Fall of 2013, I experienced a trip cancellation due to a medical issue. As I am under 65, I charged my flight on a premium charge card which carries this insurance (\$2,500 per person). My claim was settled in 2 weeks. So, if you have charge card insurance and Johnson Insurance, you may be able to have a combined claim up to \$8,500. Hopefully, you will never have to use it.

#### Dispensing Fees/Drug Costs: Shoppers Drug Mart

In June 2013 at our annual RTO/ERO benefits seminar, a representative from Shoppers Drug Mart told us that Costco was able to purchase medications cheaper than SDM and that is why their drugs are slightly more expensive. SDM, with which we have a partnership, was unwilling to lower their dispensing fees or price match meds with Costco for RTO/ERO members.

#### **Costco:**

- 1. You do not need to be a member to purchase medications.
- 2. The prescription costs for generics are slightly lower.
- 3. Dispensing fees are \$3.89 per prescription.
- 4. Prescriptions can be ordered over the phone or by email and mailed to you free in 4-7 days.

#### **Future Issues:**

*Why should I continue my Extended Health Benefits since I am over 65 and ODB provides for my needs?* 

The answer is just too long for this column. I will address this issue in the next newsletter.

The application criteria and eligibility for RTO/ERO scholarships was amended to read:

• Applicant is a resident, Canadian citizen or landed immigrant.

• Applicant is a child, grandchild, niece, nephew, grandniece, grandnephew, son-in-law, daughter-in-law or step-child of an RTO/ERO member.

• In the case of teaching programs, applicant is enrolled in the last year of a program that will directly lead to a career in teaching in Canada and the completion of the program provides the applicant with teaching credentials that are recognized by the appropriate provincial teacher regulatory body.

• In the case of all other programs, applicant is enrolled in the last year of a program that is recognized at Canadian publicly-funded colleges or universities.

## Pension and Retirement Concerns



I have included some recent information that has been sent to District 31 from the Provincial Pension & Retirement Concerns Committee. The provincial Committee meets three times each year and provides regular reports to each District.

#### **Pension Tidbits:**

ACARP survey (<u>www.carp.ca/wp-content/uploads/2013/</u>/<u>/11/CARP-CPP-Poll-Report1.pdf</u>) indicated that 53% of its members wanted Canada Pension Plan Contributions increased so benefits can be expanded. The federal government will not consider this option.

Jim Leech retired as CEO of OTPP at the end of December 2013. He co-authored a new book entitled "The Third Rail" about retirement savings, the state of Canadian pension plans, some of the challenges that other jurisdictions have faced and what they did to repair the programs. It sounds like a good read.
